


ORDER

Government of Rajasthan vide gazette notification dated 17th November 2008 has appointed Rajasthan Knowledge Corporation Ltd. to promote IT literacy in Rajasthan State. The course 'RS-CIT' is also approved by Government of Rajasthan vide above gazette notification under DOIT. The secretary to Government, DOIT, Jaipur vide letter No. F.7(103)/DOIT/Deptt/08/ML-65 dated 2-04-09 has approved the fee for the course 'RS-CIT' as Rs.2300/- including Rs.250/- as examination fees. The Managing Director, JdVVNLtd, Jodhpur has approved these fees rates to all the employees of JdVVNLtd, who willingly wish to undergo this course subject to the following conditions :-

1. The Head of office is authorized to issue approval to the No. of such employees, so that the work of office should not suffer:
2. The employees are permitted to attend the courses conducted by the franchisees of Rajasthan Knowledge Corporation Ltd, in the batches of 8 AM to 10 AM and 5 PM to 7 PM and in this case in the morning batch the employees will be permitted to attend office by 11 AM (instead of 9.30AM and for evening batch the employees will be permitted to leave office by 4.30 PM (instead of 6.00 PM).
3. The fees of Rs.2300/- will be paid by JdVVNLtd, by placing miscellaneous advance against the employee concerned and will be cleared only if he clears in the examination conducted for this course, failing which the fees amount will be recovered from the salary of the employee. In case if any employee wants to repeat the exam, the fees of examination Rs.250/- will be borne by the employee.
4. The concerned head of office will record this training in the service book of the employee along with the result of examination.
5. A quarterly compiled statement of total No. of employees and the No. of employees undergone this course with the result shall be intimated to this office.
6. No employees should be allowed to undergo this course for more than one time on JdVVNL's cost.




